#### ABSTRACT

This research mainly focus on the relationship between microfinance services and entrepreneurship development. The research investigates the impact of microfinance services on entrepreneurshipdevelopment of small scale enterprises that are aiming for growth and development in Bardagoriya rural municipality at Kailali district. The research showed the role of entrepreneur skills, investment level and the situation of entrepreneurial environment to the member of microfinance for entrepreneurship development.

The research used questionnaire as an instrument of primary data collection. Tables and simple percentages were used in data presentation. The relevant and needed data are collected through journals, newspaper, periodicals, bulletins, magazine's, published and unpublished reports from various sectors. Similarly, the primary data is collected through sample survey, questionnaire, observation, direct interview as well.

The research concludes that microfinance institutions over theBardagoriya rural municipality identified to be one of the key players in the financial industry that have positively affected individuals, business organizations, other financial institutions, the government and the economy at large through the services they offer and the functions they perform in the economy. The purpose of the paper is to examine the impact of entrepreneurship education and training on the development and enhancement of entrepreneurial skills that may be essential to improve ventures' effectiveness.

This result is basically from the MF program. Thus, the study may include NGO relating microfinance, cooperative, and other microfinance running from commercial banks.
