



Abstract

There is a need for public trust to readjust the policies with which they operate as the recent transformation in the national's policy and planning that can no longer accommodate the old principles. Although the issue of reconstruction has been in existence for quite a long time, not until recently has disaster management begun considering the possibility of embedding the public trust on governance into disaster management. In developed countries disaster management has maintained through public trust over the years; this however is not the case in other developing countries. As disaster events happen to be a universal phenomenon that inevitably brings the nations together, this study seeks to understand disaster resilient relevant areas within the subject of public trust development. And also explore the existence of loop holes within the past disaster management practices that needs adjustments. The purpose of the investigation is to analyze the use of variables in the course of handling the disaster aftermath and categories them into different units of public trust on governance practice. The Disaster management team consisted of the government of Nepal in collaboration with the different stakeholders. I used systematic sampling method for selecting study area and the respondents. The feature of the respondents reside in same ecological zone but divergent in natures like the age, level of income, gender, ethnicity, education, family size, religious etc.

The questionnaire was developed on the basis of the quality and trust of public institution during the reconstruction phase. It was also customized with the local respondents. The draft questionnaire was discussed in the group of academic and practitioners. The final questionnaire was prepared. The questionnaire was designed in English language to collect the data.

Mangkha VDC, newly known as Balephi Village Council of ward no 7, of Sindhupalchok district was my research area. There are 330 household of this area which is my unit of analysis. Among them 95 household is my sampling. The thesis is measured under these data analysis
