Abstract

The title of the present dissertation is 'Case in English and Maithili Language: A Contrastive Study' which shows the similarity and differences between the case system of both the languages to find case and difficulty between both the languages. Naturally, common things emphasize on the case and dissimilar things assert on the difficulty. It aims at finding similar or equivalent cases of English and Maithili language on semantic level. However, the case marking system is different in both of the languages.
