Abstract

This research work analyzes failure of humanism in Charles Dickens's *Oliver Twist* that set against the background of the Victorian English society, with churches and government institutions of that time failing to deliver on needs and expectations of working class people and poor children. To be human means to be entitled to getting humanly love, compassion, self-respect and treatment along with fulfillment of needs and humanly considerations, a poor orphan child like Oliver is continually subject to cruelty, deprivation and humiliation at the hands of authorities. This research tries to unveil the face of the corrupt social institutions and show material quest of the Industrial Age as the major contributing factor behind the miseries facing the lives of the working class people and decline in human values.

In the novel, orphan boy Oliver suffers a series of abuse and misfortunes and becomes in the underground world of London pickpockets and criminals, exposing the hardships of life faced by the working class largely owing to faulty social institution and values. The Poor Law provisioned that the poor could only receive government assistance if they moved into government workhouses. But money was taking place of humanly considerations; such workhouses became the place where the poor were systematically subject to all kinds of inhuman practices including utmost abuse, exploitation, starvation, humiliation and injustice. The tragic story of the orphan child shows the corrupt nature of government officials and destructiveness of the social institutions workhouses of that time that were supposed to ensure respectful survival of the poor and children.
