ABSTRACT

Female Community Health Volunteers (FCHVs), through their voluntary services have served as an important source of information for their communities, a link with government health services and a source of direct services in a number of important areas. FCHVs have contributed extensively to the health and well being of their communities, in particular to the women and children in rural areas of Nepal.

The study was carried out in the southern VDCs of Parbat district during April 2009 to March 2010 with the general objective to explore the contribution of FCHVs for primary health care and their understanding and roles for the prevention of infectious and communicable diseases in the study area.

A total of 63 FCHVs, some health officials and community members from seven VDCs were taken as the respondents in the study. All of current FCHVs were literate, majority of them were from privileged families (few Dalit FCHVs) and of reproductive age (age between 21 and 45). FCHVs have utilized the available health services and the adoption of preventive health practices among community members as voluntary health educators and promoters, community mobilizers, referral agents and community-based service providers in areas of health as per the trainings received.

They have played an important role in contributing to a variety of key public health programs, including family planning, maternal care, child health, vitamin A supplementation/ de-worming and immunization; and infectious and communicable diseases at the community level. About 65% FCHVs of the study area reported that they provide information and education on the infectious diseases affecting their locality and refer suspected infectious disease cases to health facilities for diagnosis.

FCHVs are perceived as strong promoters of community health care services as well as social leaders of the community. The FCHV Program has undoubtedly contributed towards women's empowerment. Being permanent residents, has been an added advantage to the community, especially in preventive health care services through outreach at the household and local group level.
