#### **Abstracts**

This research attempts to compare "supplement" and "contrapuntal reading". These tools reveal the marginalized and thereby counter the centre. However, the most significant difference between them is that the former is bound within textual space whereas the later takes any text as a form of cultural discourse and locates it in context. Besides, the former establishes the play by subverting hierarchy whereas the perspective of alterity remains in the later. Application of supplement in Conrad's \*Heart of Darkness\* reveals that the theme of "exploration of the self" and supplements to the "exploration of the evil" whereas reading of the same text contrapuntally shows it as purely colonial though the earlier critics saw it as anti-colonial.
