Dividends	Dividends are taxable to the shareholder.
Capital gains	Capital gains are taxable to the owner of the asset.
Interest	Interest is taxable to the owner of the asset.
Retirement	Retirement income is taxable to the recipient.
Charitable	Charitable contributions are deductible from taxable income.
State and local	State and local taxes are deductible from taxable income.
Medical	Medical expenses are deductible from taxable income.
Education	Education expenses are deductible from taxable income.
Energy	Energy-related expenses are deductible from taxable income.
Other	Other expenses may be deductible from taxable income.
