Abstract

The main aim of this study entitled "Difficulty faced by Dalits students in learning mathematics" is to analyze the causes of difficulties faced by Dalit students in learning mathematics. In particular, the study attempts to overcome these difficulties through the analysis of the causes. This research is qualitative in design with case study approach. For the analysis of the study, the researcher selected three schools of Nawalparasi district, from where 5 Dalit students were sampled (2 boys and 3 girls). Classroom observation form and interview guidelines to students, subject teacher and parents were used to collect data. In addition to this, unstructured interview of selected students, teachers and parents was also taken to analyze difficulties.

Based on reviewed literature and different concepts of theories, data have been analyzed and interpreted to find out the causes of difficulties faced by Dalit students. It was found that learning environment at home and school, language, interpersonal relation, teacher-students interaction, gender discrimination, poverty, irregularity, lack of parental involvement in the school, lack of belief and support and teaching method have emerged as the major causes behind the difficulties in learning mathematics for Dalit students.

In conclusion, the research finds that the guardians and parents of the Dalit students have not regularly kept a close watch on their children's study at home as well as in the school. Besides, favorable learning environment at home and school has not improved for Dalit children to be motivated to learn mathematics.
